On June 10, 2025, Soudure Industrielle Max Inc. ("SIM" or the "Company") filed an assignment in bankruptcy and C.S. Adjami Inc. ("CSA") was named as trustee to the bankrupt estate of SIM ("Trustee").

CSA is currently acting in its capacity as Trustee and not in its personal capacity. Please note that the term "Trustee" used in this tender document ("Confidential Information Book") refers to CSA, but only in its capacity as noted above.

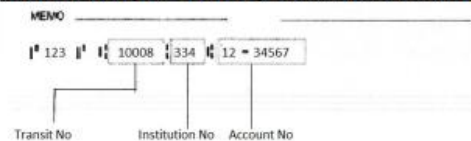

7. All offers must be signed by a person duly authorized by the entity making the offer.
8. The Trustee has no obligation to accept or even consider any offer and reserves the right to reject any offer and/or any offer, including the highest. Acceptance of any offer is at the sole and absolute discretion of the Trustee. No person may withdraw or cancel an offer before the notice of acceptance or rejection of the offer by the Trustee.
